Mr. Geddes: The Finance Committee discussed the 2015-2016 school year contracts and contract rollovers. The majority of the contracts remained flat year over year which is a positive in regards to budgeting. Flooring work will begin at the High School and the Collins school. Additionally the Public Address System (PA) in the Collins School will be refurbished.

Mr. Sarno: Mr. Sarno sat in as the Chair of the Governance Committee this month. Policy changes from the Department of Education (DOE) can be mandated, recommended, or suggested to change policy in order to meet DOE requirements. The twelve changes listed under Governance Motions 1 and 2 on page twelve (12) of this agenda are suggestions, mandates, or recommendations made by the state. The District works in conjunction with a company who reviews District Policies.

Mrs. Pereira: On March 30th the District Participated in Read Across America; the date of the event was adjusted due to PARC Testing. The Integrated Preschool Program will be employed again in the 2015-2016 school year. Thirty six students (36) registered, twenty (20) students attended the Reading Session of the SAT Prep Classes.

Mr. Sarno: The forty four (44) motions under the Personnel Section of the agenda pages 15 - 28 include the annual renewal of staff as well as eight (8) teacher and one (1) custodial retirements which will be recognized in June.

Mr. Brown: The Committee reached out to the local radio station WBNJ 91.9 and is excited to implement a weekly radio show on station. The show (slotted to begin in the next two or three weeks) is called On the Bench with John Germano and will be centered on sports and student activities. Barnegat Brag Sessions will also be recorded on campus and featured on the radio station. The freshman Student Government Association will be hosting a car wash at the Collins School on May 31st. Mr. Brown also gave recognition to Coach Nicolini for her work hosting a basketball clinic/practice for District elementary and middle school students.

CODE OF ETHICS

Board of Education

A school board member shall abide by the following Code of Ethics for School Board Members:

1. I will uphold and enforce all laws, state board rules and regulations of the State Board of Education, and court orders pertaining to schools. Desired changes shall be brought about only through legal and ethical procedures.
2. I will make decisions in terms of educational welfare of children and will seek to develop and maintain public schools that meet the individual needs of all children regardless of their ability, race, creed, sex or social standing.
3. I will confine my board action to policy making, planning, and appraisal, and I will help to frame policies and plans only after the board has consulted those who will be affected by them.
4. I will carry out my responsibility, not to administer the schools, but, together with my fellow board members, to see that they are well run.
5. I will recognize that authority rests with the board of education and will make no personal promises nor take any private action that may compromise the board.
6. I will refuse to surrender my independent judgment to special interest or partisan political groups or to use the schools for personal gain or for the gain of friends.
7. I will hold confidential all matters pertaining to the schools which, if disclosed, would needlessly injure individuals or the schools. In all other matters, I will provide accurate information and, in concert with my fellow board members, interpret to the staff the aspirations of the community for its school.
8. I will vote to appoint the best qualified personnel available after consideration of the recommendation of the chief administrative officer.
9. I will support and protect school personnel in proper performance of their duties.
10. I will refer all complaints to the chief administrative officer and will act on the complaints at public meetings only after failure of an administrative solution.
