2. Barnegat High School:

- a. Mr. Bengal was another success this year, raising thousands for the senior class. Always a fun night for all at BHS, the auditorium was filled with standing room only.
- b. The senior class also held their annual auction, raising several thousand dollars for the class. This money along with Mr. Bengal goes to offset many of the fun things at the end of their senior year including the prom, and project graduation.
- c. The Bengal Theatre Company presents The Addams Family. The play begins April 28th through 30th at 7PM, and May 1st at 2pm. Tickets can be purchased on our website.
- d. Students are busy making last minute decisions on their college and career chooses in the upcoming weeks.

3. Russell O. Brackman:

- a. In late March, the Brackman Jazz Ensemble performed at the annual Southern Regional High School Jazz Festival. We received a rating of "GOLD", as well as best saxophone section. Seventh Grade student Deegan Melchiondo received an award for outstanding soloist. The students said they had a great time and a wonderful experience.
- b. Mr. Wald and his chorus students are working on a video for the song "Strong" that he and the students wrote for cancer awareness. They are going to be debuting the video and having the song go live on iTunes the night of our concert, May 18th. The video involves his students as well as members of the Barnegat community that have been going through cancer treatment and survivors. Additionally, there is a story about "Strong" that will be running in a bunch of the local papers!
- c. In Mrs. Grasso's class, the students completed a bridge challenge. They were asked, before they received any instruction, to build a bridge using only 100-popsicle sticks and Elmer's glue. Afterwards, they learned about the structural design of six different types of bridges (arch, beam, cable-stayed, cantilever,

suspension and truss). Then they were given the challenge to choose one of those types of bridges (except beam) and build the bridge of their choice using 200-popsicle sticks and Elmer's glue. The results were pretty amazing. To test the structural integrity of the bridges, weights were placed on them to see how much the bridges could hold before they broke. The bridge that held the most weight was from was made by Samantha Algozzini and Whitley Francois. They built a truss style bridge that finally broke under 130 pounds.

- d. On Monday April 11th, ten students from Brackman competed in the Optimist Oratorical Contest at Barnegat High School. Everyone who participated did a fantastic job and our school very proud. The third place winner was Noah Jeremias. The second place winner was Ryan Schager and the first place winner, who will go to compete at the regional competition in Reading, Pennsylvania was Isabella Bartz. Great job everyone and good luck to Isabella at the Regionals next month!
- e. Bulldog City hosted the spring pep rally which debuted our new bulldog mascot! Whereas the bull dog remains our mascot, the old bull dog costume, "Biscuit", is just really old, 182 in dog years old! The new Bulldog needed a name as well; therefore, Bull Dog City came up with a few names that our entire student body voted on. The winning name is "Bandit" the Bulldog!
- f. The Brackman cafeteria has a newly renovated seating area known as the Bulldog Café. Mr. Rowland, our Food Service Director, and Mrs. LaGuardia, our School Business Administrator, designed and facilitated an awesome cafeteria renovation project that was completed over spring recess! We are so grateful for this renovation; the students are so excited about the additional seating area that includes 4 round high top tables and stools, a long bar counter with seating, and a new concession service counter.

4. Cecil S. Collins:

- a. The Collins school PTA hosted movie night this month. Families enjoyed a night out with pj's and popcorn. It was a great family event.
- b. PARCC testing is underway. With our excellent staff, Mrs. Blaney's leadership, and the assistance of the Technology department all is going smoothly.
- c. Our 5th grade students will be traveling to Trenton for a field trip to Washington's crossing. This should be a great educational experience for our 5th grade students.
- d. We will also be celebrating Arbor Day and Bring Your Child To Work Day this Month.

5. Joseph T. Donahue:

- b. JTDS successfully completed the PARCC tests with a 100% participation rate.

CODE OF ETHICS

Board of Education

A school board member shall abide by the following Code of Ethics for School Board Members:

1. I will uphold and enforce all laws, state board rules and regulations of the State Board of Education, and court orders pertaining to schools. Desired changes shall be brought about only through legal and ethical procedures.
2. I will make decisions in terms of educational welfare of children and will seek to develop and maintain public schools that meet the individual needs of all children regardless of their ability, race, creed, sex or social standing.
3. I will confine my board action to policy making, planning, and appraisal, and I will help to frame policies and plans only after the board has consulted those who will be affected by them.
4. I will carry out my responsibility, not to administer the schools, but, together with my fellow board members, to see that they are well run.
5. I will recognize that authority rests with the board of education and will make no personal promises nor take any private action that may compromise the board.
6. I will refuse to surrender my independent judgment to special interest or partisan political groups or to use the schools for personal gain or for the gain of friends.
7. I will hold confidential all matters pertaining to the schools which, if disclosed, would needlessly injure individuals or the schools. In all other matters, I will provide accurate information and, in concert with my fellow board members, interpret to the staff the aspirations of the community for its school.
8. I will vote to appoint the best qualified personnel available after consideration of the recommendation of the chief administrative officer.
9. I will support and protect school personnel in proper performance of their duties.
10. I will refer all complaints to the chief administrative officer and will act on the complaints at public meetings only after failure of an administrative solution.
