VI. SUPERINTENDENT'S COMMENTS/CURRICULUM UPDATE

Mrs. Becker: Under Superintendent's comments, Mr. Bing.

Mr. Bing: Very quickly, we have started Back to School Nights and if you look at the calendar you will see dates for those this week as well. We are entering into a partnership with Veridian Energy this year with a partnership that entails a fundraiser. Veridian is a supplier of energy and also green energy and for every resident of Barnegat that signs up for Veridian they donate money to the school on a monthly basis. It is not changing your current electric bill, you will still receive your exact same bill from the exact same company, but when you sign up with Veridian they go out and work with suppliers. Most people do not know who their supplier is. They go out to the market and find a cheaper provider and also find a provider that uses greener energy. It should also decrease your electric bill anywhere from 1-5%. So every resident that signs up, it is simple you go to the website for Barnegat Schools and sign up and it will generate money on a monthly basis.

All sports are now in session. The girl's field hockey is now 7 and 0, they just beat Brick today. There is a very good chance they will be making the playoffs; they did last year. The team is extraordinarily good. The other fall sports have also kicked off so if you can stop by to one of the games, please do that. October 15 the Education Foundation will be holding the Trick or Trunk over at the Donahue parking lot. For those of you not familiar with Trick or Trunk, it is

simple. You pull you car up into a lot and open your trunk and put a Halloween display in your trunk instead of your front yard. Kids go around and judge and also trick or treat for the night and they offer the prizes at the end. It is a fundraiser for the Education Foundation. Each car has a \$15.00 registration fee, all the candy you can eat. If you just want to bring your children down to trick or treat it is a \$2.00 registration per child.

The grade books for the high school are now on line and middle school will be up by the middle of next week. Oh, both are up so parents/students can go online 24/7 and check their grades and homework.

Also the first two weeks of the Safe Routes to School Program are finished and we have been working very closely with the police in town to make some provisions on that plan. Those revisions included crossing guards and adding sidewalks and fencing.

We also want to adopt the District Goals for the 2010 - 2011 school year:

Student Achievement

- 1. Make a safe-harbor for students with special needs in the district
- 2. Increase number of students scoring in Proficient range, above-comparable DFG districts in Language Arts Literacy in the writing strand.

Facilities

- 1. Increase efficiency in the use of energy (alternative energy sources, i.e., solar, etc.)
- 2. Establish and maintain a Comprehensive Maintenance Plan in partnership with completing SDA projects.

VII. PRESIDENT'S REMARKS

Mrs. Becker: As part of that process under the President's Remarks we will review the Board Goals:

As part of the Barnegat School District's compliance with the New Jersey Quality Single Accountability Continuum or QSAC, the Board of Education participates in the establishment of board and district goals which outline objectives aimed at enhancing the educational quality of students and the efficient and productive governance of the district's policy and direction by the Board of Education members.

For the 2010/11, the Barnegat Board of Education has decided to continue to move forward with objectives established in 2009/2010.

Those goals are to:

- 1. Continue to develop Board certification for both the whole Board and individual members.
- 2. Continue to implement the annual evaluation calendar for the CSA and the Board Self Evaluation process to improve Board focus and efficiency.

3. Support the CSA as the educational leader for the district.

Additionally, over the past year the Barnegat School District, like all school districts in the state of New Jersey, has had to navigate its way through many unpleasant and difficult choices in the changing educational climate.

We, as a Board and with the advisement of district administration, were challenged to reduce the cost to taxpayers, while still expected to provide the level of education and enrichments so well associated with our Barnegat Schools. For those of us who were part of the budget process, both before and after its defeat, they will attest that it was the least satisfying attribute to sitting in these chairs... knowing that as we had to absorb increases in budgetary items - each cut equaled more than just a dollar sign.

In late August the Atlantic City Press ran an investigative report on the impact of the cuts made by the state and their effects to local districts. Even considering that here in Barnegat for three years in a row the Board and administration have produced budgets that were less than the year prior - a feat that Barnegat had the distinct honor of ranking #1 - we earned a new 1st place recognition.

The facts presented showed that out of 5 counties with a total of 73 school districts Barnegat topped the staff reductions with 75 people laid off. Coming in 2nd and 3rd with 57 and 51 layoffs were Galloway and Middle Twp. The next highest in 4th and 5th were Millville and Hammonton with 30 layoffs and then of the remaining 68 districts - that's 68 districts -their average was 5 layoffs per district.

I hope that those of you who are here listening can understand the impact to our community, that even while we reduced our operating budget to less than last year, the budget was still defeated. Even though the district took a proactive stance with regard to the over adequacy issues in transportation, and even as the Township looked for more and more cuts to our student programs and activities, the district still maintained a quality education and activities for every child. Please know that further challenges await our community, the Board and this district - some challenges are within our control and others are beyond and leave us at the merciless unknown of next year's state budget. I encourage you, the parents and community members, to come forward and communicate with the district and your local representatives, not only those things which have raised your dander or aggravated you, but with suggestions and ideas.

If we are to navigate the changing face of education - it would be in our best interest that we all grab a paddle and row in the same direction - otherwise our children may end up lost in an undertow of political rhetoric. Thank you.

Bernard Laufgas, Schooner Ave.: Discussed Matt Nelson's accomplishments and acknowledgments.

Second, my favorite subject...how are we doing with the marquee?

Mr. Bing: Dr. Saxton met with the township engineers last week and also the provider of the marquee so a final price will go before the committee next month.

Mr. Laufgas: Mr. Montenegro did you forget what you promised me last month?

Mr. Montenegro: Absolutely not, I authorized the expenditure for the donation.

Mr. Laufgas: Inaudible. Donated \$500.00 to the History Club.

The donation was accepted and Mr. Laufgas was thanked for this generous donation.

Mr. Bob Russo: Inaudible; discussed problems for some people not being able to access computers to get grades, etc. on line. He would like an alternative for those who cannot access computers. Discussed fundraisers for field trips to raise money to help.

Scott Sarno: Thanked Mr. Germano. Discussed volunteer policy and who is required for a background check. A volunteer should be a volunteer since they are working with the kids. What exactly do you want to say, one day, four or five days, what is a volunteer?

Second in the August agenda you hired six people and I want to know where the money is coming from. All the hiring was already done. Personnel #11 you are hiring another security and transportation, where is that money coming from. Obviously if they were budged for they

would have been hired in June and July. Is the \$699,000 being spent before we get it and it is supposed to be spent next year.

Also, you are voting on stipends that are costing over \$250,000. Is there anyway to reduce stipends? Why can't people volunteer to go so things are not taken away from the children? We need to save money; last month we were worried about paying for the superintendent's tuition, is there any way to reduce the amount of stipends? If we get more people to volunteer we won't be taking money away from our children.

Under finance, #6, for workshops, you have all of these workshops and two were the 17th; a lot were payroll. So you are approving something that already passed. How are you going to something and you do not know what it is costing, it says N/A. Are they free? Hopefully you can answer these questions.

Mrs. Becker: Well, obviously, if it says N/A it means there is no charge. If there was a charge it would say TBD if we did not have a cost yet. As far as stipends for activities, those budgets were reduced by 15% going out the gate. Finance is constantly looking for ways to combine stipends wherever they can and obviously you know that having sat on negotiations when you sat here. There are issues that cannot be done just by Executive decision. As far as continued reference to approving the education for the CSA, your wife sat in on the interview committee and that was the agreement that was made. We knew he was undergoing school at the time and we committed to hiring him and allowed him to complete his work up in Great Meadows and he did not start here until July. It was not something that anyone was unaware of.

Mr. Bing: The big change with Field Trips is that district is not paying for them any more. The only districts that pay are Abbott districts and that has been for years. In regard to volunteer policy the letter I sent out did not denote any days; what it did denote was that I did not think we needed to do a background check on PTO mothers who bring cupcakes into a birthday party and make them pay \$27.00 for a background check. That is what the letter stated; I used that as an example. We are working with the Barnegat Little League that has a system to do background checks that is a lot cheaper than the \$27.00. I reached out to that company; I believe they do it for \$3.00-\$5.00 per person. If we can get that price then as I noted in the letter I would like to expand it to everybody. Anybody who comes into the schools, even the Moms who bring the cupcakes will have to pay the \$3.00 for the background check. We have a T-Pass system in all the schools that does a background check as soon as the person is at the front door, but as you get more volunteers we will be doing a standard blanket check.

Inaudible from audience.

Mr. Bing: We received this letter when it was in the newspaper. Districts could not get any mention of this before it hits the papers.

Mr. Allison: I downloaded this at 4 p.m. and the Asbury Park Press had it this morning. We put in place this year something called a position control roster and we have a set list budgeted amount for positions of each function. We cannot add people to that list without budget. If we

are hiring somebody it means they are in the budget, we do not have spare money. You might see us adding a position, but my roll is to know where to get the money to pay for it.

Inaudible from audience.

Mrs. Becker: Non-renewal means any staff member that is non-tenured that has chosen not to be rehired. There is a position there but they choose not to fill it with that specific individual. In some cases we were hoping that perhaps with enrollment we would not need to fill every single one.

Mr. Bing: We waited this year pretty much for the last moment, along with many other school districts, for enrollment numbers to see if we could cut some positions based on special ed students and children moving into the district. In regard to the Christie statement, "the U.S. Department of Education requires the Education Jobs funds be spent by September 2012. With your staff and budget set for the 2010-2011 school year, I urge you to be mindful of how and when these funds are spent. While record levels of total federal, state and local funding have been made available to schools in recent years, the next budget cycle promises to be challenging. Therefore, please consider reserving this one-time funding for the 2011-2012 school year if possible".

Mr. Allison: I want to make one more comment on stipends because I think it is really important to communicate and you have the facts. You will see on the Agenda there are 39 people for sixth-period stipends, we cut that in half. Last year we spent over \$255,000. We had to cut some elective courses at the high school to do that, but that \$136,000 looks like a big number but last year it was over \$250,000. In terms of the active school stipends, we cut them between 26-28%; last year the high school had \$80,000 and this year they only got \$60,000. They had to allocate that across the board.

Mrs. Becker: Anyone else who would like to come up?

Jake Taylor: I have a question, what is the L.G. Settlement Agreement?

Mr. Montenegro: That was a Resolution for litigation relative to employee in the district that reinstated an employee to that position.

Jake Taylor: What did it cost the district?

Mr. Montenegro: I did not cost the district anything monetarily. There was no monetary outlay from the district. It solely reinstated the position. The insurance carrier paid their component but the district paid no monetary payment for this.

Jake Taylor: Did we lose the agreement? They won their lawsuit against the district, correct?

Mr. Montenegro: That is incorrect. The district was successful in the litigation, however it was appealed and while appealed the parties came to a resolution of the litigation.

Jake Taylor: I want to comment on the solar power. I heard a lot of schools in the area and I think there has to be publicity on this. I travelled to other school districts and I think we have to get the publicity out there. It is good for the taxpayers and we need to build our reputation up. The other thing on the Edwards School on the appraisal, I go to a lot of meetings, I think there have been some discussions with the township. We need to have as much information on the Edwards School as possible. Is there any truth to the fact that the property reverts back to the person that gave us the property when the school was built?

Mr. Bing: There are two steps taken today. There has been no discussion with regard to the town privately or publicly with regard to that building. We have had two or three public meetings last year about the Edwards School to get suggestions from the public; we averaged anywhere from 5-15 people at those meetings. There was one party that was interested in using it for a drama school and another for something else.

Jake Taylor: As long as all discussions are made public and we can have input, I'll be satisfied.

Mr. Bing: One of the goals from last year was the Edwards School and to start moving on that promptly. That is why we see those two items on the agenda.

Mr. Montenegro: This to get the full title search to confirm that there is no such reversal and it is a clean title to the property.
