On behalf of the administrators, teachers, staff, and the Board of Education, I enthusiastically welcome you and your family back to another school year. All of the following information is important; please give your full consideration to each item. Items A-D are accessible through your child's Parent Portal account which enables you to grant or not grant permission. Item A is not required for students in Pre-K through 3. If you do not have internet access, hard copies will be provided for you through your school's main office. The following items are required each year and are accessible through your child's Parent Portal:

- A. Family Life & HIV/AIDS Awareness Program Permission Form – permission is required for participation/exclusion in the programs (for Grades 4-12 only).
- B. Potassium Iodide (KI) Pill Permission Slip – indicate whether you want/do not want your child to receive the KI pill in the event of an emergency.
- C. Potassium Iodide (KI) Fact Sheet.
- D. Photo/Media/Internet Use Guidelines and Permission Form.

Listed below are items that are being sent home with the student:

- A. Student Profile Sheet – please review and make any necessary changes. Please sign the bottom and return to the Main Office.
- B. An Emergency Health Information Card. It is essential that the school be able to contact you at any time for various situations. Please complete and sign both sides of the card and return them to the Main Office.
- C. Code of Conduct Verification Form. Please sign and return to the Main Office.
- D. Parent Portal Access Form. Please fill out and return only if you do not have a Parent Portal account or would like to add a new student to the account.
- E. Important information from your School Nurses.
- F. 2017-2018 School Calendar.
